- Pool closes at 7:30 p.m.
- No "late night swims" scheduled at this time.
- The sliding board will not be open at this time.
- The 'daily passes' are <u>not</u> available for purchase during the 2020 pool season.
- The 'season passes' and 'shared passes' are available and can be purchased.
- Face masks are encouraged to be used in the pool areas outside of the water.
- Social distancing of 6 feet is to be followed.
- Limit the number of people in the restrooms so social distancing can be accomplished.
- Lounge chairs are cleaned before the pool opens. When you leave the pool for the day, place the back of the chair in the seated, fully upright position, and notify staff to re-clean them.
- Pool staff will be cleaning surfaces regularly.

DEFINITIONS

Share Pass: Group (5) + 1: *Includes unlimited daily access to both the Reamstown Pool and the Denver Community Pool for all members within the group during the 2020 pool season. See definition of "Group" below.*

Pool Share Pass: Student: *Includes unlimited daily access to both the Reamstown Pool and the Denver Community Pool for the student member during the 2020 pool season.*

Group Membership Pass (5) + 1: A Group Membership + 1 includes up to five (5) people in the group for a flat rate. One additional person to the group can be added to the pass for an additional fee of \$25.00. At least one member of the group must be 18 years old or older.

Cocalico Swim Team Student: A reduced student rate is available for all members of the Cocalico Swim team.

PARKS

The playgrounds, courts, and facilities are closed, however walking or jogging within the parks by practicing appropriate social distancing is permitted.

Please remember that when the COVID-19 restrictions are lifted, all parks in East Cocalico Township are closed after dark with the exception of prior permission for Special Events. The parks are closed at dark for public safety and security reasons. Any person found in the parks after dark can be charged with trespassing.

Also, taking your dog for a walk is a wonderful way to exercise! Your pet will enjoy it as much as you! Please be respectful when walking your dog by keeping your dog on a leash, clean up after it, and properly dispose of the waste at home. East Cocalico Township Ordinance 2007-03 states fines can be imposed up to \$600.00 for dog waste left behind.

REAL ESTATE TAX PAYMENTS

At their April 16, 2020 meeting, the Township Supervisors agreed to a countywide resolution (Resolution 2020-04) to extend late payments of real estate taxes to December 31, 2020 without a 10% penalty.

This is intended to give relief to residents who may have lost income during the coronavirus pandemic. For the resolution to go into effect, it must be approved by every Lancaster County municipality and school district.

BUILDING PERMIT TO PICK UP?

The East Cocalico Township Municipal building is closed, however if you need to pick up and pay for a building permit, please call 717-336-1720 before you arrive at the Municipal building, and staff will be sure to watch for you.

If you need to submit a Building Permit Application, please fill out an application on-line, then mail, fax, or e-mail the application. Once received, the Zoning Officer will review the application and call when it is ready for pick-up. Any fees associated with the permit are due at the time of pick-up.

STREET LIGHT NOT WORKING?

Have you noticed a street light not working? If so, you can still submit the information. Please write down the two numbers found on the pole (for example: 46544 and S33296), note the nearest address, and report the information to PP&L at 1-800-342-5775, or call the Township and leave a message (717-336-1720) or e-mail Township@eastcocalicotownship.com, and staff will report it for you.

WOODY WASTE ACCESS CARD

The Woody Waste drop-off facility is open. It is located behind the Township building for the residents of East Cocalico Township for tree limbs, branches, and stumps less than 12" diameter. *No grass! No leaves!* To use the facility an application must be filled out along with a \$15 check. This is a annual fee. The annual clock starts the month your card was activated.

For an application, visit the Township Website and click the Recycling tab. Fill out the application and return with a \$15 check (made out to East Cocalico Township). Mail to: East Cocalico Township, 100 Hill Road, Denver, PA 17517, or place your application and payment in the drop-box located at the Municipal building's front doors.

When your application and fee are received, an access card will be mailed back to you the same day.

CENSUS REMINDER — IT'S THAT TIME

As of May 16, 2020, East Cocalico Township's rate of self response to the census is 75.3%. The state's is 62.4%, this is good, however, we need to have everyone's participation. Due to COVID-19 the Census Bureau has made operational adjustments, which means that you now have more time to respond. Respond to www.2020census.gov, phone 844-330-2020, or mail back the questionnaire sent to your home as soon as you can. If you do not, eventually a census enumerator will visit your home, most likely between August and October. It is our hope by that time, our self response rate is 100% and we can pass that information along to you in our next newsletter. Your information is protected and is confidential. Federal law protects your responses, which cannot be shared with law enforcement, immigration agencies, or housing authorities.

2019 ANNUAL DRINKING WATER QUALITY REPORT

Each year the East Cocalico Township Authority is required by the PA Department of Environmental Protection to provide our customers with the Annual Drinking Water Quality Report for the previous year. This report contains important information about the quality of the drinking water we supply to our customers. Beginning July 1st you can view the 2019 Annual Drinking Water Quality Report by typing the following web address into your browser:

AUTHORTY BILLING CYCLE

From time to time we get calls from customers asking when the next water/sewer bill will be mailed. Occasionally a customer will misplace their bill and not realize it until the payment due date has passed. Except for our larger customers, the Authority reads meters and mails bills on a quarterly basis. The Authority's yearly billing cycle is as follows:

Meter Read Date	<u>Usage Period</u>	Mail Date	<u>Due Date</u>
January 2	October, November, December	January 15	February 15
April 1	January, February, March	April 15	May 15
July 1	April, May, June	July 15	August 15
October 1	July, August, September	October 15	November 15

Also it is the Authority's policy to only mail water and sewer bills to the owner of the property, not to tenants. If you are a property owner and don't receive your quarterly bill within a few days after the mailing date or you misplace it, please give the Authority a call at (717) 336-1731. We'll be happy to issue you a replacement bill so you can keep your account current and avoid any late penalties.

SWIMMING POOL REMINDER

Property owners with swimming pools are reminded that in keeping with the East Cocalico Township Authority's Rates, Rules, and Regulations no relief is given from sanitary sewer charges for filling swimming pools or for any other domestic or residential use that does not involve sanitary sewer disposal. Also when draining your pool please remember that the Pennsylvania Department of Environmental Protection prohibits the discharge of any pool water to a storm sewer or land in which a storm sewer is accessible. Property owners who discharge swimming pool water to any waters of the Commonwealth without a permit are in violation of the Clean Streams Law and may be prosecuted. The East Cocalico Township Authority encourages property owners to properly dispose of pool water and with prior notification will allow discharge to the public sanitary sewer system.

COVID-19

The Authority is following guidelines established by Governor Wolf and the PA Department of Health during the COVID -19 pandemic. Until stay at home orders are lifted, the Authority office at 102 Hill Road will be closed to the public and Board meetings (held the second Thursday of every month) will be conducted online using Zoom. During this time, office employees will continue to work from home and the Authority's water and sewer operators will work staggered shifts in order to minimize contact with each other and exposure to the virus. Throughout these trying times, the Authority remains committed in its mission to provide safe and dependable water and sanitary sewer services to all of our customers. 
